

- 1) It is a Condition Precedent of Insurers' liability that cover provided by this Insurance is subject to receipt and approval by the Insurers of a signed and satisfactorily completed proposal form within 30 days of inception

- ii) If subsequent to inception, the Insured provides risk information differing to the material facts that the Insurers relied upon when underwriting this risk as evidenced by the proposal form, questions and subsequent enquiries the Insured may prejudice coverage provided by this Insurance, resulting in the terms and premium being changed or the voiding of this contract from inception
- 2) It is a Condition Precedent that there are no known or reported Claims or circumstance likely to give rise to a Claim at inception
- 3) It is a Condition of this Insurance that the Insured must contract with customers on the basis of Egyptian International Freight Forwarding Association (EIFFA) standard trading conditions. Any movement of Cargo requiring special trading conditions outside the scope of EIFFA conditions are covered subject to Insurers prior written agreement only.

Any Claim arising from the movement of Cargo without specific agreement by Insurers will be determined on the basis of EIFFA Standard trading conditions (Liability & Limitations: SDR 666.67 per package or unit or 2 (two) special drawing rights (SDR) per gross kilogram of the goods lost, damaged, misdirected or recognized international conventions and conditions whichever applicable.

4) Subcontractors Clause

In case of Appointment of subcontractors/agents) the following applies: -

Insured will use best endeavors not to subcontract any part of the insured services other than on back-to-back conditions with liabilities accepted by the insured or as imposed under National or international Law or Convention

Any loss caused by a subcontractor whose contractual liabilities are more restrictive than the Insured's, will be subject to a deductible of 5 % of the damage or loss subject to a minimum deductible USD 1,000.00 any one Claim.

- 5) this Insurance specifically excludes any Claim where the Insured agrees to "hold harmless" any party or waive rights of recourse in respect of the Insured services.
- 6) this Insurance excludes any Claim where the Insured is engaged to perform and supervise the movement of Project Cargo

Project Cargo is defined as any oversize (dimensions greater than one FEU HIGH CUBE) and or overweight load exceeding 40 tones or special cargo that may require a special rig different to a standard rig for it's lifting and or cargoes requiring a tandem lift (use of two cranes simultaneously) and by way of example shall include but not be limited to: construction machines, cranes, front loaders, backhoes, prebuilt homes, bridge beams, generators, windmill propellers and towers, industrial equipment, agricultural machines

- 7) This insurance excludes any liability, costs and expenses resulting from Insured's services as an Insurance Agent, in particular when offering cargo insurance to customers
- 8) This insurance excludes any Claim arising out of storage in excess of 30 days unless agreed by insurers and included within the Insured services above
- 9) This insurance excludes any Claim relating to loss of or damage to Cargo stored in the open
- 10) This Insurance excludes any Claim where two or more containers share a reefer point whether fixed or mobile on a "rotated basis"
- 11) This Insurance excludes Claim relating to loss or damage to Cargo arising from handling, loading, stowage or unloading of the Cargo (including over-loading beyond permissible capacity), by the sender, the consignee or person acting on behalf of the sender or consignee.

12) Cargo Theft

This insurance excludes theft of cargo whilst a vehicle is left unattended on a public road or a non-secured parking area. For the purpose of this clause, a secured parking area must comply with the following:

- a) entry and exit controls and;
- b) 24-hour supervision and;
- c) Perimeter fencing

All doors, openings and windows are securely locked and fastened, all keys are removed from the vehicle and any other security protections fitted to the conveyance are put into operation

Choice of Law and Jurisdiction:

This contract shall be governed by and interpreted pursuant to the laws of Egypt and each party agrees to submit to the exclusive jurisdiction of the courts of Egypt.
